DEAR READERS,

The AEB is the main representation of foreign investors in Russia. It is the largest and most influential foreign business association in Russia, which includes more than 500 leading European and international companies operating in Russia.

In recent years the AEB has gained significant influence in terms of promoting of interests of European business in Russia. Not only are we privileged to have a close working relationship with the European Commission and the European Parliament, but the AEB is currently Russia's main partner with regards to EU – Russia economic relations.

In 2016, we launched the AEB Arbitration Court (AAC) which is planned to operate as a dispute resolution mechanism for both AEB member and non-member companies willing to use the AEB Arbitration Court as an alternative to conventional litigation. It aims to provide a venue for the resolution of international commercial disputes.

The AEB also pays considerable attention to its fruitful working relationship with the press, and looking at the increase of AEB mentions in the press compared to last year, it is clear that these efforts are not in vain. Currently, AEB events are covered by both the Russian (Kommersant, Vedomosti, Izvestia, RBC, 1 Channel, Interfax, TASS, etc.) and foreign (Bloomberg, BBC, BILD-Zeitung, Caijing, Der Spiegel, Deutsche Welle, Die Welt, DWN, El Mundo, El Pais, Euronews, Europa Press, La Tribune, Le Figaro etc.) media.

Our publications, the most important being the Position Paper and the AEB Business Quarterly, are currently delivered to major organisations, business centres and hotels in Russia and beyond.

We would like to express our gratitude on behalf of all our members to the members of the Board, the Council of National Representation, the Auditing Commission and all the Committee Chairs for their hard work and dedication in representing and promoting the interests of AEB member companies, and for their commitment to forging stronger economic ties between the EU, Russia and the Eurasian Economic Union. Through our Committees, Subcommittees and Working Groups, the AEB will continue to work for the benefit of European businesses operating in Russia.

As the next pages will show, 2016 was quite eventful. We hope that this Annual Report will show all our members that the AEB is in fact doing everything in its power to lobby the interests of its member companies and this is a tradition we most definitely intend to continue in the years to come.

THE ASSOCIATION OF EUROPEAN BUSINESSES (AEB)

- main representation of the European investors in Russia, from small-size newcomers to major multinational corporations. The Association also includes a number of key Russian, American, Japanese and other companies;
- is a unique organisation developing cooperation between Russian and European business circles. The AEB mission is to improve the business and investment climate in Russia in the interests of its member companies and promote a favorable image of Russia abroad to improve the business development conditions inside the country and attract foreign investors;
- annually organises 100+ conferences, seminars, briefings and roundtable discussions dedicated to vital aspects of running a business in Russia. Regular speakers at the Association's Dialogue with European Business include Ministers of the Russian Government, Members of the State Duma of the Russian Federation, heads of key economy agencies and organisations, heads of administrations of Russian regions, official representatives of international financial organisations, independent experts and leading European and Russian businessmen.

Committees. Committees are the backbone of the AEB. 534 Members of the Association promote their interests via participation in various committees. There are currently 65 committees, sub-committees and working groups representing companies from various industries.

Lobbying. The Association promotes its members' interests by closely cooperating with the EU authorities and holding regular consultations with relevant officials. The European Commission is regularly consulted with the Association in connection about financial and commercial relations with the Russian Federation. The multi-level structure of the bilateral relations strengthens the role of the European business community. AEB's lobbying is based on the maximum transparency, high professionalism and a mechanism of reacting to new challenges which has been adjusted over many years.

Consulting. The Association engages European and Russian experts to consult Russian officials and its member companies in legal, financial and economic matters. In particular, practical support is offered in safe and transparent investment, and issues of human resources and corporate management are discussed.

MEDIA RELATIONS

The number of media requests remained very high in 2016. Press meetings. This year a number of mass media representatives made company presentations for AEB members. They included Mikhail Fishman, Editor in Chief, The Moscow Times, and Dmitry Gruzdev, Deputy Editor-in-Chief, Rossiya Segodnya International Agency (RIA – Novosti). **Press releases.** In 2016, the AEB communications department issued a number of press releases, including monthly press releases with the results of Russian car and LCV sales, the results of the annual AEB-Gfk Rus survey "Strategies and prospects for European companies in Russia", press-releases on the sales of new construction equipment, messages about AEB lobbying activities, committee initiatives and AEB briefings.

Online activities

In September 2016, the AEB launched the Russian version of its website www.aebrus.ru/ru. Since then our visitors have been able to view information on AEB activities and news in both languages – English and Russian. This has helped to increase our daily online audience.

In addition, the AEB announced the launch of its special BSP (Business Services Platform), a lead-generating platform where potential clients can request quotations for different types of services (legal, consulting, auditing, etc.) from AEB member companies by filling out a short form.

The request is automatically forwarded to a number of companies from the pool of service providers and is then processed by the BSP participating companies — they contact the potential client, clarify all the details and then the client receives a number of offers and selects the one that best meets his or her requirements.

Publications

- The AEB continued to publish its Business Quarterly magazine with a circulation of 16,000 copies.
- As ever two versions of the Real Estate Monitor were released four times during the year, in print and online.
- As always, the AEB continued to release its Position Paper which contains the aggregated experience of AEB members: over 500 companies working in the Russian market, who are well acquainted with the hard end of doing business in this exciting and rewarding country. It has been distributed in Brussels and to the state authorities of the Russian Federation as well as among all the AEB members.
- The AEB also continued to publish its annual magazine "HR sector in Russia" with analyses and expert views on the current HR market.



COMMITTEE ACTIVITIES, 2016

The AEB Agribusiness Committee has been actively lobbying on important issues such as Decree 719 (on identifying the criteria for "Made in Russia" production), Decree 740 (consumer characteristics and efficiency of agricultural machinery) and Decree 81 (disposal fee). A number of letters have been written to address these issues – namely, to the Ministry of Industry and Trade, the Federal Antimonopoly Service, Government Apparatus, Ministry of Agriculture.

As a result, the Working Group on amendments to Decree 719 was established within the Federal Antimonopoly Service with the inclusion of AEB Agribusiness Committee experts.

Another important issue that was successfully lobbied on by the Committee was Technical Regulation 031/2012 for agricultural tractors – explicit proposals on amendments to it were submitted and a number of meetings with the Eurasian Economic Commission and the Belorussian Institute for certification and standardisation were held throughout the year. The amendments proposed by the Committee technical experts were accepted by the Eurasian Economic Commission Council on 30 November 2016.

A successful meeting with Rosagromash (Association of Russian Agricultural Manufacturers) was held in July 2016 in order to discuss the positions of European and Russian producers on technical regulations and other issues. The Agribusiness Committee will join its efforts with the AEB Construction Equipment Committee to improve the procedure for obtaining the electronic passport for self-propelled machines.

COMMITTEE ACTIVITIES, 2016

In 2016, the AEB Airline Committee was actively engaged in lobbying for equal airport charges for European airlines in line with the airport charges paid by Russian airlines. For this purpose, on 1 November 2016, the AEB met Igor Artemiev, Head of the Federal Antimonopoly Service, in order to discuss this issue and the FAS established the Working Group on airlines within its structure to work on this issue in close collaboration with the Ministry of Transport of the Russian Federation.

COMMITTEE ACTIVITIES, 2016

The year 2016 was the 19th year of AMC operations within the AEB.

For the 10th year the Committee continued to operate an online sales data exchange system for its members, which remained almost the only up-to-date and reliable source of passenger cars (PC) and light commercial vehicle (LCV) sales statistics in Russia. Following a well-established tradition, the results of 2015 and forecast for 2016 were made available to the media at the annual AMC press conference which also provided the press with an opportunity to talk to heads of automobile companies about important issues related to the automotive industry.

One of the key issues of AMC members throughout the year continued to be the practical implementation of the provisions of the Code of Conduct (CoC) developed and adopted by the AMC in cooperation with the Federal Antimonopoly Service and the Ministry of Industry and Trade. By the end of 2016 twenty (20) members had joined the Code of Conduct. Based on the results of the analysis of the implementation of the Code of Conduct conducted and discussed by both the FAS and AEB, the members developed and made public Recommendations on the Code of Conduct implementation. The work continued. AMC members and the ROAD (Russian Dealers Association) met and discussed problems at the FAS Expert Council where it was resolved to set up a working group to boost cooperation among businesses working in the automotive market. The Working Group will start operating in 2017.

The AMC continued to try to promote its proposals on amendments to the Consumer Protection Law (CPL) in order to eliminate the risks to manufacturers/distributors and CoC members arising after the full implementation of the Code of Conduct.

Technical Regulations of the Customs Union, TR CU 018/2011, "On the Safety of Wheeled Vehicles" which entered into force on 01.01.2015 remained on the Agenda of the Committee throughout the year 2016. The importation and production of vehicles not equipped with the emergency call system/device but still holding a valid OTTS (vehicle type approval) was the key issue requiring immediate solution.

The new procedure for processing the OTTS recently established by Rosstandart needs to be reorganised. Taking into account the large number of issues to be addressed to the certification bodies as well as to Rosstandart, the Certification/Homologation Group of the AMC initiated round table discussions with the involved parties which will begin in January 2017.

The introduction of digital passports for wheeled vehicles deserved the special attention of the Committee, which is a member of the dedicated Working Group operating at the Eurasian Economic Commission. This will be the highest priority of the agenda in 2017.

Throughout the year the Committee representatives participated in other important events where they spoke on behalf of the AMC, such as the Russian Automotive Forum organised by Adam Smith conferences, Rosavtodealer-2016, the 94rd International Scientific-Technical Conference of the Association of Automobile Engineers: "Technical Regulations of Automotive Vehicles", and others.

The other main issues on the AMC agenda in 2016 were:

- EAC labeling of spare parts.
- Development of the 2025 automotive strategy. Members participated in all discussions held by Minprom and NAMI.
- Luxury tax rate.

Throughout the year the AMC published monthly press-releases on car sales statistics that are widely used by the automotive and business media across Russia and abroad. The press coverage of issues addressed by the AMC and its work in general further increased in 2016.

An AMC representative is participating in the work of the UN EC Working Group on the development of UN rules on a permanent basis.

The Committee continued to strengthen cooperation with national and international automotive associations: the ACEA (European Automobile Manufacturers Association), OAR (Association of Russian Automakers), OICA (International Organisation of Motor Vehicle Manufacturers), ROAD, VDA (German Association of the Automotive Industry), and the local authorities and industry officials.

COMMITTEE ACTIVITIES, 2016

In 2016, the Committee continued its cooperation with its key partners, namely:

- The Committee continued to collaborate with the regulator the Central Bank of the Russian Federation: on 22 April
 the Committee held a meeting with representatives of the Central Bank regarding the localisation of databases and the
 implementation of CBR Regulation 397-P; on 13 October the Committee held a meeting with representatives of the
 Banking Regulation Department of the Central Bank to discuss issues related to the implementation of CBR Instruction
 154-I on remuneration rules. Also, the Committee sent a number of letters with comments on how to improve banking
 regulation and requests for clarifications to the Central Bank.
- The Committee collaborated with the Ministry of Finance, the Ministry of Economic Development and the Ministry of Justice and sent comments and requests on issues related to banking regulation.
- The Committee communicated with the State Duma, in particular with the Financial Market Committee and the State Building and Law Committee.
- The Committee continued to cooperate with the European Commission, namely with Jonathan Hill, the Commissioner for Financial Stability, the Financial Services and Capital Markets Union and the European Commission regarding the registration of the National Clearing Centre (NCC) at the European Securities and Markets Authority (ESMA).

In 2016, the Committee worked in the following key areas: legal issues and the localisation of databases; anti-money laundering (AML) and compliance; HR issues. Furthermore, the group of CEO level representatives of the Committee's member banks held regular meetings to discuss developments and activities in the banking industry, including a dinner with the European Union Ambassador to the Russian Federation Vygaudas Ušackas.

In addition, the Committee chairperson, Committee members and coordinator participated in a number of meetings held by the Working Group on Financial Institutions and Capital Markets of the Foreign Investments Advisory Council (FIAC) and continued to collaborate with it.

COMMITTEE ACTIVITIES, 2016

The Commercial Vehicles Committee (CVC) was founded at the end of 2008 as a spin-off of the Automobile Manufacturers Committee (AMC) in order to focus on the specific needs of commercial vehicle manufacturers in the Russian Federation.

The main issues discussed in the Committee in 2016:

Automotive strategy 2025

On 18 January 2016, the President of the Russian Federation presented the government the task of creating a strategy for the development of the automotive industry and automotive components production until 2025. Work in this area was carried out in the spring and summer of 2016, but the AEB member companies were not involved on a regular basis. The Committee made every effort to make the efficient market (real competition, transparent and predictable "rules of the game") as one of the criteria for the successful implementation of the strategy.

Determination of the country of origin

On 14 July 2014, Resolution No. 656 of the Government of the Russian Federation was adopted, which determines the criteria for access to public procurement for commercial vehicles. Another Resolution, No. 513, dated 9 June 2016, significantly tightened these criteria, which further restricted competition during public procurement. At the same time, informal and unpredictable restrictions also appeared regarding procurement by companies which act in compliance with Federal Law No. 223-FL, dated 18 July 2011.

Mandatory equipment with emergency call devices

The Technical Regulation of the Customs Union "On the safety of wheeled vehicles" introduced the requirement of mandatory equipping of buses and trucks carrying dangerous goods with emergency call devices from 2016, and of all vehicle types from 2017.

Electronic passport

On 1 July 2017, the electronic passport will be introduced for all vehicle types. The Committee is taking active part in the working group in the EEC regarding the implementation of the ELPTS in the Eurasian Economic Union.

On 18 February 2016, Ilsur Akhmetshin, the Acting Chairman of the AEB Compliance & Ethics Committee, Country Integrity Officer, ABB Russia, took part in the V Annual International Compliance Association (ICA) Conference: Compliance: Optimisation and effectiveness. In 2016, the AEB was an informational partner of the conference. The aim of conference was to discuss the unification of approaches taken by international organisations and government agencies with compliance regulation and supervision, and to assess liability subject to the presence or absence of compliance management systems. In his address Mr. Akhmetshin presented the AEB Compliance & Ethics Committee, its goals, work and plans.

On 29 March 2016, the AEB Compliance & Ethics and HR Committees held the joint event: Compliance and HR: Crossfunctional collaboration in a company. The aim of the event was to discuss ways and methods to achieve cross-functional collaboration between HR and Compliance functions in a company and to exchange best practices. It was co-moderated by Ilsur Akhmetshin, the Acting Chairman of the AEB Compliance & Ethics Committee, Country Integrity Officer, ABB Russia, and Michael Germershausen, Chairman of the AEB HR Committee, General Manager, Antal Russia.

On 24 November 2016, the AEB Compliance & Ethics Committee met with Artem Tsirin, Head of the anti-corruption legal issues division, Institute of Legislation and Comparative Law under the RF Government, to discuss enforcement practices and the latest legislative initiatives related to the Article 19.28 of the Code of Administrative Offence.

COMMITTEE ACTIVITIES, 2016

The Construction Equipment Committee (CEC) was established in February 2008 to unite and represent the interests of the CE industry players in Russia.

Retail sales statistics are considered as crucial data by all CE manufacturers. The AEB Construction Equipment Committee's statistics programme has proven its efficiency since its inception in 2008. Today, companies such as Bell Equipment, Caterpillar, Chetra, CNH, Doosan, Hitachi, Hyundai Heavy Industries, JCB, John Deere, Komatsu, Kraneks, Liebherr, RM-Terex, and Volvo are highly satisfied with the results of the programme. The reports are available within the Russian Federation at both the federal and regional levels. It is also worth mentioning that the Committee also started reporting on Kazakhstan in January 2014.

The main issues discussed by the Committee in 2016:

1. Disposal Fee

Being environmentally responsible companies, AEB members and manufacturers of construction equipment are aware of their responsibility for collecting and processing goods that have lost their consumer properties. The Committee members are not against the disposal fee but consider that Government Decree No. 81 "On the utilization fee in respect of self-propelled machines and (or) trailers" was introduced with high disproportions (e.g. the fee for articulated and dump trucks is from 2.5 million roubles per machine).

A meeting with the Ministry of Industry and Trade was held on 10 May 2016, as a result of which the Committee sent a letter with proposals for amendments to this resolution.

2. Localisation

The Committee worked with the Ministry of Industry and Trade of the Russian Federation to amend Decree No. 719 "On the approval of the criteria for classifying industrial products as products which have no analogues produced in the territory of the Russian Federation, as well as the criteria for classifying industrial products products products produced in the territory of the Russian Federation". Work will continue to allow optimal localisation levels in business operations,

which are subject to the efficiency of capital investment and market conditions. In these regards, a working group within the Federal Antimonopoly Service was created to analyse Decree No. 719.

The Committee cooperates with other national construction equipment industry associations. In 2009, the AEB CEC became a member of the Committee for European Construction Equipment (CECE) and participates annually in the CECE meetings. In April 2013 the AEB CEC and KOCEMA (Korea Construction Equipment Association) signed a memorandum of understanding.

COMMITTEE ACTIVITIES, 2016

The AEB Construction Industry & Building Material Suppliers Committee represents within the AEB a variety of businesses with very heterogeneous industrial and commercial backgrounds and a diverse set of interests, but with construction materials as a common bond. The Committee was born in 2010 in the belief that there are many issues that need to be monitored and made aware of, and initially they were mostly related to producers of building materials.

In 2016 the Committee focused on building a common position on the following issues:

- technical standards and regulations;
- environmental sustainability and green standards;
- technical control and guarantees in construction;
- energy efficiency in construction;
- product certification and counterfeit products;
- transparency and reliability of information referring to construction materials;
- vocational education and training centers;
- "best available technique" guides (BREFs);
- criteria for classifying objects that have a negative impact on the environment;
- gas supply in Russia;
- guarantees in construction.

On 22 September 2016, Vitaly Bogachenko, Chairman of the Committee, participated in the AEB Real Estate Day Annual Conference, where he spoke at a session: Distributing the wealth: are the Russian regions ready to catch up?

In October 2016, Vitaly Bogachenko participated in a roundtable discussion entitled Smart City at the International Investment Forum in Sochi.

In 2016, Committee members discussed on multiple occasions the issue of guarantees in construction with the participation of insurance and construction companies.

The Committee members strongly believe that a dialogue between experts with different backgrounds and government officials could bring benefits to the Russian construction sector.

In 2016, Heating Systems Manufacturers, the working group of the Committee continued to conduct its sales statistics.

COMMITTEE ACTIVITIES, 2016

A significant positive result of the CPC lobbying activities together with the Russian Union of CPP Manufacturers was the amendments made to Sanitary Regulations and Standards 1.2.2584-10 "Hygienic safety requirements for the trial, storage, transportation, sale, use, disposal and recycling of pesticides and agrochemicals" in order to harmonise the provisions of Section XX "Safety requirements for the disinfection of vehicles, equipment, containers, premises and working clothes" with international principles and standards. In the amended version registered by the Ministry of Justice on 1 June 2016, the contradictions regarding the CPP container management international standards were excluded.

The next logical step for the development of the Container Management Scheme was the establishment of the company ECOPOLE by the AEB and the Russian Union of CPP Manufacturers in June. This company focuses on organising the collection and utilisation scheme for all interested parties and controlling compliance with safety requirements.

One of the key events of the year was the press conference "Results of 2016 agricultural year for seed and CPP producing companies: modern technologies for increasing the productivity of the Russian agriculture" (together with the Seed Committee). It was focused on presenting new technologies and investment projects, and supporting new technologies and products that companies provide for their customers - Russian farmers (training and information programmes, field days, agricultural technology days, and others). The press conference clearly demonstrated the significant contribution made by international companies - the CPP and seed producers - to Russian agriculture.

COMMITTEE ACTIVITIES, 2016

The Customs & Transport Committee and its members have been working to identify challenges in the application of customs laws throughout its entire existence. Currently intensive work is in progress identify gaps and discrepancies at the Eurasian Economic Union (EAEU) level of legislation and at the level of national regulatory acts enacted to develop provisions and institutions within the EAEU Customs Code. Work is also in progress to improve previously enacted customs legislation regulations in relation to regulatory impact assessment.

The purpose of the Committee's work is not only to identify gaps and discrepancies in legislation but also to jointly develop recommendations on their elimination with experts from the business community, which are mainly aimed at improving regulatory documents.

The Committee acts as an intermediary in constructive dialogue between the regulatory bodies and the business community on customs and transport issues in order to increase the effectiveness of government control in the aforementioned areas and to improve the business environment.

In April and November 2016 the Committee organised two meetings with the Minister for Customs Cooperation of the Eurasian Economic Commission Mukay Kadurkulov to discuss the most important issues relating to customs administration and the outcomes of the joint AEB-EEC mission to Italy. In June 2016 an AEB/EEC delegation met with representatives of the Italian Customs Agency and the customs authorities of the Emilia - Romagna and Liguria regions. The participants learnt about the "fast corridor" customs clearance procedure in the port of Genoa and the simplifications for authorised economic operators also in the context of the new EC Customs Code adopted in May 2016.

The AEB Energy Committee stands as an interface on business opportunities and issues of concern to European energy companies operating in the Russian Federation. Therefore, the Committee sustains and develops its links to relevant state authorities in Russia, such as the RF State Duma, Ministry of Energy, Ministry of Finance and Ministry of Economic Development. The Committee also acts as an interface between the European energy business and Russian companies, such as Gazprom and others.

The AEB Energy Committee sustains its traditional cooperation with bilateral and multilateral entities in Russia, such as the EU – Russia Industrialists Roundtable (IRT), International Business Congress (IBC), Petroleum Advisory Forum (PAF), Foreign Investment Advisory Council (FIAC), promoting active interaction on business-to-business and business-to-government levels. The AEB Energy Committee supports the AEB's position as an official partner of the annual Russian Petroleum and Gas Congress (RPGC) in Moscow and other events supported by the AEB through participation in its Program Committee, delegating its members as chairmen and speakers to RPGC. The Committee's activities are focused on energy policy strategic issues, investment climate, energy market conditions, and environmental protection issues, including global climate changes.

One of the important sources of information and influence tools for the Committee is its regular Position Paper, which is a highly professional status document reflecting the views and approaches of the European companies towards the obstacles to making business in Russia and proposing real solutions. The Position Paper is widely distributed among petroleum and energy sector stakeholders both in Russia and abroad, including EU headquarters in Brussels.

The Committee advocates that EU - Russia relations on energy matters should be based on stability in strategic perspective, mutual advantage and delivery of commitments. Such relations must include a balanced and transparent approach to the security and diversity of energy supply and demand, commercial attractiveness and reciprocity.

The Committee has working relations with the Russian Federation (RF) Ministry of Energy, RF Duma Committee for Energy, Russian Energy Agency, RSPP Committee for Energy Policy and Energy Efficiency, and U4E (Union of French Enterprises for Energy Efficiency and Ecology).

One of the Committee's key projects in 2016 was the ninth annual survey: Strategies and prospects for European companies in Russia. The survey has become a highly valuable source of first-hand information that provides an overview of the investment potential and opportunities in Russia and highlights the key challenges faced by AEB member companies, and the strategies adopted while doing business in Russia. The results of the survey were announced on the eve of the St. Petersburg Economic Forum: the official presentation was held on 14 June 2016 in Moscow and on 15 June 2016 in St. Petersburg. The survey and its results were well cited in the media.

Among other important event was the briefing by Alexey Komissarov, Director of the Industrial Development Fund (31 May 2016). During the event Mr. Komissarov spoke about the Industrial Development Fund, its key areas of focus and measures of support, special investment contracts (SPICs) and their benefits, the status of "local producer", investor liability, differences in comparison to other state support programmes, adaptation of legislation, etc.

In addition to the Committee events, Stuart Lawson, Finance and Investments Committee Chairman, participated as a co-moderator in the briefing with Gabriel Di Bella, Resident Representative of the International Monetary Fund in the Russian Federation: Russia: from stabilisation to growth, held on 2 November 2016.

To cover leasing issues, within the Finance and Investments Committee there is the Leasing Subcommittee chaired by Sergey Ivanov, General Director, IKB Leasing AO.

In 2016, the AEB Leasing Subcommittee discussed and worked on a number of issues related to the leasing industry. The key topics included reforming the leasing industry (under regulation by the Central Bank), amendments to leasing related legislation, the creation of self-regulatory organisation(s) (SROs) in the leasing industry, the collection of payments (incasso), the implementation of the law on personal data protection, subsidies to banks and leasing companies for car purchases on credit, the registry of leased assets under Federal Law No. 360-FL dated 03/07/2016, etc. The Leasing Subcommittee started to collaborate with the Central Bank (in particular, with the Department of Financial Stability): the subcommittee chairman and members participated in discussions, working groups and meetings organised by the Central Bank. Furthermore, it was proposed to organise a section on full-service automotive leasing (within the subcommittee) in order to discuss issues related to operational leasing.

COMMITTEE ACTIVITIES, 2016

On 7 April 2016, the AEB Health & Pharmaceuticals Committee held its roundtable meeting at the VII Northern Dimension Forum in St. Petersburg. The event was dedicated to the topic Import substitution in the Russian pharmaceutical and medical industry: new opportunities to build a success story. The event was co-chaired by Sergei Smirnov, Chairman of the AEB Health & Pharmaceuticals Committee, ans Evgeniy Kardash, Executive Director of the Scientific and Technological Pharmaceutical Company Polysan. The participants included regional administration officials, businesspeople and experts from the pharmaceutical industry.

Nadezhda Shevtsova, Lecturer at the Department of Pharmaceutical Management and Economy of the Saint-Petersburg State Chemical-Pharmaceutical Academy, Deputy Head of the R&D Department, spoke on the localisation of medications and procurement for the federal reimbursement programme; Alexander Khadzhidis, Chairman of the Association of Clinical Pharmacologists, Chief Clinical Pharmacologist of the Healthcare Committee of the City St. Petersburg, shared his vision on pharmaceutical market prospects and new financial opportunities; Yana Kotukhova, Government Relations and Public Affairs Manager at Sanofi Group Russia, presented the company case regarding the transfer of advanced technologies for the production of Russian pharmaceuticals; Maria Borzova, Manager of Life Sciences Projects, Vegas Lex, spoke on applying the RF Government's Decree 1289: challenges and opportunities. The experience of applying the RF Government's Decree No. 102. On 19 April 2016, the Association of European Businesses and the Federal Antimonopoly Service held a joint press conference to present the Code of Good Practice in the Pharmaceutical Industry. The main objective of the code is the self-regulation of the pharmaceutical industry in the Russian Federation, as well as the establishment of fair, open and honest rules of competition in the pharmaceutical industry.

Igor Artemiev, Head of the Federal Antimonopoly Service, underlined the impact of the code on the pharmaceutical market. Yuri Litvishchenko, Chairman of the AEB Health & Pharmaceuticals Committee, CEO, Chiesi Pharmaceuticals, made a presentation on the main provisions of the new code. The press-conference was followed by a Q & A session.

On 19 May 2016, the AEB held a roundtable meeting on the legal and practical aspects of the localisation of production in Russia at the St. Petersburg International Legal Forum. The participants discussed issues such as ways to localise in Russia, the criteria for goods to be considered as locally made (e.g. Decree 719), the obstacles that companies face when implementing localisation projects, and much more. Members of the AEB Health & Pharmaceuticals Committee who localised production in Russia were represented in the event.

At the St. Petersburg International Legal Forum, the code of good practice for the pharmaceutical industry was presented at the Roundtable meeting organised by the Federal Antimonopoly Service.

On 27 September 2016, the AEB took part in The Russian Competition Week, which is the key annual event in the field of competition policy in Russia organised by the Federal Antimonopoly Service of the Russian Federation (FAS). Yury Litvishchenko, Chairman of the AEB Health & Pharmaceuticals Committee, CEO, Chiesi Pharmaceuticals, participated in the joint meeting of the Working Group of BRICS and the Working Group for Research on Competition Issues in the Pharmaceutical Sector, and delivered the presentation: Competition in the pharmaceutical market as the main precondition for a fair price. Senior officials of the foreign competition authorities and international organizations and representatives of the central office and regional offices of the FAS discussed the best global practices in the field of competition protection and advocacy.

On 1 November 2016, the Health and Pharmaceuticals Committee Chairman Yury Litvishchenko took part in an AEB meeting with Igor Artemiev, Head of the Antimonopoly Service, which was dedicated to the discussion of several issues from different industries including the pharmaceutical sector.

On 7 November 2016, the Health and Pharmaceuticals Committee Chairman Yury Litvishchenko took part in an AEB meeting with A. Besprozvannykh, Head of Regional Industrial Policy, Ministry of Industry and Trade, to discuss the special investment contract and the work of the department.

On 21 November 2016, the AEB Health and Pharmaceuticals Committee members met with Denis Cherednichenko, General director, United Innovation Corporation Rosatom, and Yaroslav Senshin, Director for Development, Rosatom, to discuss the experiment with the voluntary labeling of drugs.

From the very outset, the AEB has been supporting Prix Galien Russia, which recognises outstanding work to improve the human condition by means of biomedical and technological innovation. On 1 December 2016, the Prix Galien Russia Awards Committee honoured excellence in research, development and innovation in the biopharmaceutical industry at its third awards ceremony. Members of the AEB Health and Pharmaceuticals Committee took part in the ceremony.

On 5 December 2016, members of the AEB Health and Pharmaceuticals Committee took part in an AEB meeting with V. Osmakov, Deputy Minister of Industry and Trade, to discuss localisation and special investment contract issues.

On 22 March 2016, the AEB HR Committee held its thirteen's annual HR Conference entitled "Russia and the New Reality for HR". The conference was focused on the practices applied by leading companies under the shift of economy in the sectors of compensations & benefits, recruitment, assessment, training & development, and labour law. The panel discussion by CEOs "Strategic Business/HR Partnering Under the New Reality" was a special separate session, closing the conference. The panelists shared with the audience their vision on management and decision-making in the new market conditions.

On 19 October 2016, the Committee held its open event organized by the Recruitment Subcommittee and entitled "Digital HR: In Transformation?". The digital age has brought considerable change to both our professional and personal lives. With digital technology changing the way business is done, the HR functions of organisations are also looking for new ways to adjust digital technologies for hiring and managing talent and for implementing business transformations. On 12 December 2016, the Committee held its business meeting organised by the Compensation & Benefits Sub-Committee and entitled "Overview of Salary Survey in Russia". This meeting has been held annually by the Committee for the last nineteen years. The main goals of this business meeting are to provide AEB members with the results of surveys giving current and comprehensive information on the base salary for the year, bonuses received and other factors related to salaries, provide information on the main trends and future outlook of Russia's salary market, and to assist the AEB Members in establishing appropriate pay levels for different levels of responsibility.

The briefing by Maxim Topilin, Minister of Labour and Social protection of the RF, held on 5 February 2016 for AEB members served as a starting point for the study of important issues in close dialogue with Mintrud. One of them is flexible shift schedules and amendments to Article 103 of the RF Labour Code "Shift Work" – the project is now supported by other AEB members.

Another important topic lobbied for by the AEB HR Committee/Labour Law Subcommittee is competition clauses. The issue was first announced by AEB members at a meeting with Minister Topilin in February 2016. At the initial meeting held in Mintrud in October 2016, the HR Committee/Labour Law Subcommittee outlined the following aspects of the problem: working part-time for a current employer's direct competitors in the main workplace, the foundation of companies competing with a current employer's company, employment at a competing company after the termination of an employment contract.

In June 2016, the AEB HR Committee conducted a survey on the employment of disabled people in companies operating in Russia. The topic of the employment of disabled people is becoming a high priority in Russia at the highest political level. In order to develop the current policy applied in the Russian Federation, the AEB was approached by the Ministry of Industry and Trade of the RF with a request to help analyse the experience gained by AEB members in this regard. In 2016, the following meetings were organised and held by HR Committee/Labour Law Subcommittee:

- 24 February 2016 Meeting with the Department of Wages, Labour Relations and Social Partnership, Ministry of Labour and Social Protection of the RF, devoted to the Volkswagen Group's initiative on flexible shift schedules and amendments to Article 103 of the RF Labour Code "Shift Work"
- 19 May 2016 Meeting on disability insurance fraud with the Department for Disabled People and Pensions, Ministry of Labour and Social Protection of the RF (jointly organised with the AEB Pensions & Insurance Committee)
- 9 August 2016 Meeting with the Department of Wages, Labour Relations and Social Partnership, Ministry of Labour and Social Protection of the RF on flexible shift schedules and amendments to Article 103 of the RF Labour Code "Shift Work" – presentation of the AEB's consolidated position
- 25 October 2016 Meeting with the Department of Wages, Labour Relations and Social Partnership, Ministry of Labour and Social Protection of the RF on competition clauses

COMMITTEE ACTIVITIES, 2016

In 2016, the Committee continued to develop cooperation and held regular meetings with key state partners.

The Committee strengthened its collaboration with the regulator – the Central Bank (in particular, with the Insurance Market Department at the Central Bank). The Committee regularly provided comments and proposals to improve insurance regulation and sent a number of requests for clarifications on insurance issues to the regulator. In 2016 the Committee held a number of meetings with representatives of the Insurance Market Department to discuss the following issues: on 1 February regarding the limitations on investments in assets of related parties (structural relations); on 6 April mainly regarding the CBR Regulation on minimum standards for foreign citizens in respect of VMI and AEB comments and proposals to draft law No. 939349-6 on improving the procedure for licensing insurance entities; on 25 April regarding two draft methodological recommendations on the internal control system and internal audit (as a result of the meeting the Committee prepared and sent a table of comments and proposals to the draft methodological recommendations). Furthermore, Vladimir Sukhinin, Deputy Committee Chairman and Committee members regularly took part in the meetings and activities of the Central Bank's Expert Council on Insurance.

- The Committee continued its dialogue with the Ministry of Finance, which usually reacts positively to proposals made by the Committee. The Committee members took part in the roundtable meeting organised by the Ministry of Finance on the legislation of foreign insurers in the Russian Federation in accordance with WTO obligations on 12 July 2016.
- The Committee continued to liaise with the Federal Antimonopoly Service (FAS), and Committee representatives took part in the meetings and activities of the Expert Council on the Protection of Competition in the Financial Services Market (section on the insurance services market) under the FAS Russia.
- The Committee liaised with the government and Presidential Administration (mainly on the issue of the national reinsurance company), the Ministry of Economic Development (primarily through the procedure of the regulatory impact assessment of legal acts related to insurance), and the Federal Migration Service, and sent comments and requests on issues related to insurance regulation.
- The Committee began to liaise with the Ministry of Labour and Social Protection (jointly with the AEB HR Committee). On 19 May, Insurance & Pensions Committee and HR Committee representatives held a meeting with representatives of the Ministry of Labour and Social Protection on combating insurance fraud in respect of the establishment of disability of ineligible persons based on fictitious medical records. By Order No.577 of the Ministry of Labour and Social Protection dated 19 October 2016, a representative of the Insurance & Pensions Committee was included in the interdepartmental working group on cooperation between medical and social expertise institutions and insurance companies regarding the establishment of disability of insured persons (under the ministry).
- The Committee continued its dialogue with the State Duma Committee on Financial Markets and provided comments and proposals on a number of draft laws related to insurance.

In addition to the abovementioned, the Committee held a meeting with the Russian Association of Motor Insurers (RSA) regarding the Bureau of Insurance Histories on 7 July 2016. RSA representatives were interested in European experience with regard to the Bureau of Insurance Histories.

On 15 July 2016, the Committee held an open event: Electronic insurance in Russia, with the participation of representatives of the Ministry of Finance, the Central Bank, and the Russian Association of Motor Insurers where they discussed recent trends and developments in electronic insurance in Russia and exchanged experience and ideas.

On 20 December 2016, the Committee held the business meeting: Pension system of Russia: looking to the future, with the participation of representatives of the Association of Non-State Pension Funds (ANPF) and the Higher School of Economics. The event-goers were updated on pension reforms and the pension market, and given an overview of corporate pension programmes and solutions.

In 2016 the Committee continued its discussions regarding joining the International Insurance Law Association/Association Internationale de Droit des Assurances (AIDA). In July 2016, the AEB Board supported the request of the Insurance and Pensions Committee to join the AIDA as the Russian National Chapter. The AIDA Russian National Chapter platform is open for participation in events for companies, professionals, lawyers, students and PhD students.

On 8 February 2016, the AEB IP Committee represented by the then Deputy Committee Chair Anton Bankovskiy, Partner at CMS, and Ekaterina Tilling, Senior Partner, Tilling and Peters, met Sergey Matveev, Deputy Head of Department for Science and Technology, RF Ministry of Education and Science, to discuss the development of digital services for trademark owners and other issues of mutual interest.

On 26 February 2016, the Association of European Businesses represented by Frank Schauff, AEB CEO; Eugene Arievich, Chairman of the AEB Intellectual Property Committee, Principal, Baker & Mckenzie; Ekaterina Tilling, Senior Partner, Tilling and Peters, and Maya Limonnikova, AEB Legal Advisor, participated in the Council on Intellectual Property (IP), which was chaired by Valentina Matvienko, Chairperson of the Federation Council. The IP Council was devoted to improving the quality and accessibility of IP services. Frank Schauff presented the AEB position on key IP issues such as parallel imports, counterfeiting in the crop protection industry, forced licensing and data exclusivity in the pharmaceutical industry.

On 2 March 2016, the AEB Intellectual Property and IT & Telecom Committees jointly held the roundtable discussion: IT in relation to intellectual property rights. The event was co-chaired by Eugene Arievich, Chairman of the AEB Intellectual Property Committee, Partner, Baker & McKenzie CIS – Russia, and Edgars Puzo, Chairman of the AEB IT & Telecom Committee, CEO, Atos IT Solutions and Services. The event was organised to inform AEB members of the latest legislative changes in IT and intellectual property rights as well as current law enforcement practices.

On 3 October 2016, Anton Bankovsky, Chairman of the AEB Intellectual Property Committee, and Ekaterina Thilling, Deputy Chairwoman, met with Tamas Kiraly, Policy Officer – International Aspects of Intellectual Property Rights Directorate-General for Trade, European Commission, and Luis Portero, Head of Economic and Trade Section, Delegation of the European Union to the Russian Federation to discuss IPR issues in the EU and Russia.

On 4 October 2016, the AEB Intellectual Property (IP) Committee held its annual conference: Intellectual Property Rights: Recent Trends, Court Practices, Problems and Solutions at the premises of the delegation of the European Union to Russia. The IP annual conference serves as a valuable platform for experts in intellectual property issues. It provides opportunities for its participants to learn about the most important issues in IPR protection through face-to-face interaction with representatives of state bodies, courts and leading legal companies and it provides an important platform for discussion. The event was moderated by Anton Bankovsky, Chairman of the AEB Intellectual Property Committee, Partner, CMS. Speakers from Russian state bodies (the Federal Antimonopoly Service, ROSPATENT, Court for Intellectual Property Rights), and regional organisations (Eurasian Economic Commission, European Commission) addressed a variety of issues ranging from the development of the Eurasian trademark system and united customs register of the Eurasian Economic Union to trading of counterfeit and pirated goods in the European Union.

Experts from the AEB IP Committee spoke on Russian court practice in parallel imports; issues related to damages and claims for compensation, protection of confidential information in Russia, registration of the disposal of exclusive rights, and the mandatory pre-trial settlement of IP disputes.

COMMITTEE ACTIVITIES, 2016

The purpose of the committee's work is to create the right conditions for cooperation and the joint development of digital technologies between Russia and the EU, followed by the mutual promotion of projects on global markets. To realise the Committee goals a number of meetings were organised and held with the heads of Russian and European government agencies. On 10 March 2016 a meeting was held with the participation of Committee representatives, the AEB management and the Mass Communications Minister Nikolay Nikiforov. The following proposals to promote the development of cooperation between Russia and the EU in high-technology were put forward at the meeting:

- to establish within the ministry an expert group on the localisation of companies which have a significant share of the software market in the Russian Federation;
- to facilitate dialogue between Russian Ministry of Communications and Mass Media and European Commissioner for Digital Economy and Society, to combine EU and Russian capabilities to achieve synergies through enhanced technological cooperation.

The Committee initiatives were supported by the minister. To develop the initiative the AEB IT-Telecom Committee with the support of member companies organised a meeting between G. Oettinger and members of the board of the Association of European Businesses at the St. Petersburg International Economic Forum. During the meeting, the AEB put forward the following proposals:

- To harmonise the regulatory environment on the principle of reciprocity;
- To develop, implement and promote joint products.

The Committee continued to liaise with the RF authorities: on 1 November 2016, Gleb Vershinin participated in a meeting with Igor Artemiev, Head of the Federal Antimonopoly Service, where they discussed software localisation.

On 19 May 2016, the AEB held a roundtable discussion on the legal and practical aspects of the localisation of production in Russia at the St. Petersburg International Legal Forum. The participants discussed issues such as ways to localise in Russia, the criteria for goods to be considered as locally made (i.e. Decree 719), the obstacles that companies face when implementing localisation projects, and much more. The participants, consisting of AEB members and the state authorities, held a lively discussion on different aspects of special investment contracts (i.e. the exact preferences investors may receive, liability in the event of the violation of obligations, and more). The roundtable discussion was organised by the AEB Legal Committee.

Other related activities of the AEB: Arbitration Court activities

On 26 January 2016, the Association of European Businesses (AEB) presented the AEB Arbitration Court (AAC). Robert Schulze, President (Chairman) of the AAC, made a presentation on the rules and proceedings of the AEB Arbitration Court and introduced the Presidium.

On 25 April 2016, the AEB held a presentation on its newly established Arbitration Court (ACC) at the RTİB Russian-Turkish Businessmen Association. Robert Schulze, President of AEB Arbitration Court, informed the audience on the benefits of international commercial arbitration, the new Russian legislation on arbitration, and on the structure and rules of the ACC. The meeting participants were representatives of the biggest Turkish investors in the Russian Federation.

On 6 October 2016, the Presidium of the AEB Arbitration Court held an open event: The Future of Arbitration in Russia – Arbitration Reform and the Creation of the AEB Arbitration Court. The aim of the event was to introduce to the participants the latest legislation on arbitration in Russia and highlight the main features of the AEB Arbitration Court which was lately established to administer commercial disputes between companies. The main speakers were Robert Schulze, President of the AEB Arbitration Court; Fredrik Ringquist, First Deputy Chairman of the AEB Arbitration Court's Presidium, Partner, Mannheimer Swartling; Alexey Barnashov, Counsel, Head of Litigation (Russia), Mannheimer Swartling; and Alexandra Shmarko, Member of the AEB Arbitration Court's Presidium, Associate, Baker & McKenzie.

From more than 200 AEB members represented in the North-Western Region, about 115 companies were active in 2016 and regularly participated in the work of the Committee and its 5 subcommittees.

2016 was marked by several notional open events and business meetings held by the Committee and its subcommittees. Of particular importance were those held with the North-Western customs authorities, the Labour Inspection of St. Petersburg, the IFM, the World Bank, St. Petersburg State University, and others). 2016 was marked by a landmark event: the 20th Anniversary of the AEB in Russia.

The Committee raised and discussed with the authorities issues such as:

- Improvement of the investment climate in the region;
- Application of the TIR and customs transit transfer procedure;
- · Parallel imports;
- Draft customs code of the EEAU;
- Application of customs laws;
- Use of information technology for the customs declaration;
- · Practice of working with authorised economic operators in North-West Russia;
- Practice of the provision by the NWCA of preliminary decisions on the classification of goods under HS EAEC;
- · Issues related to customs value and other customs administration issues;
- Production localisation issues;
- · Challenges experienced by manufacturing companies in Russia;
- Labour inspection audit;
- · Attracting, onboarding and retaining employees;
- Talent management;
- Professional standards;
- Business and education;
- Outstaffing and outsourcing legislation;
- Challenges and forecasts in the construction industry of the North-Western Region of Russia;
- Current situation in the building materials market;
- New tax regulation as regards the real estate industry;
- Changes to corporate law;
- B2B vs B2C markets: consumer behaviour and challenges.

In 2016 the AEB NWRC continued to participate in the regular meetings of the Investment Councils of St. Petersburg and the Leningrad Region. In December the AEB NWRC participated in the conference organised by the government of the Leningrad Region on "Clever regulation in practice: the effective mechanism of direct dialogue between government and business when taking regulatory decisions" where the results of a survey carried out in cooperation with the administration of the Leningrad Region among AEB members who do business in the region were presented.

In 2016 the AEB NWRC became a member of the advisory Committee under the Regional Customs Authorities (SZTU) and participated in its regular meetings.

In 2016 the management of AEB met with representatives of the St. Petersburg Government and the Leningrad Regional Government, as well as with the Deputy of the Plenipotentiary Representative of the President of the RF in the North-Western Region to discuss the current situation, activities and opportunities for cooperation.

The general consulates in the St. Petersburg and European Union delegation to the Russian Federation consider the AEB North-Western Regional Committee as an adviser and reliable partner for European companies in the North-Western Region. In 2016 the AEB continued to foster cooperation with EU consulates in St. Petersburg through regular meetings with EU delegation representatives and with the general consulates and commercial staff. The AEB organised events in cooperation with the consulates, held presentations of the AEB's federal and regional work during business breakfasts at the consulates and meetings with national representative companies and potential members.

On 12 February 2016 the AEB PR & Communications Committee organised a meeting with Mikhail Fishman, Editor in Chief of The Moscow Times. The Moscow Times and its online edition (themoscowtimes.com) is now the only media platform in Russia that remains available to an international audience in English and is independent. At the end of 2015 The Moscow Times changed owners and its editorial concept. Mikhail Fishman, the new editor-in-chief and one of the most experienced Russian journalists, briefed the audience on the publication's plans to work with foreign investors in Russia, and about the unique and attractive options offered by this media platform.

On 15 September 2016 the Committee held its open event – a presentation by the Rossiya Segodnya International Information Agency. The Rossiya Segodnya International Information Agency is an international media group whose mission is to provide prompt, balanced and objective coverage of what is happening around the world, and provide the audience with different perspectives on key events. The agency is the largest Russian producer of information products targeted at an international audience, the business community, government bodies and a wide range of users. The following topics were covered by the speakers at the event: the main areas of focus of Rossiya Segodnya, monitoring of the information agenda through RIA Novosti's news ticker, strengthening the company's presence in the media though the agency's interactive projects, Rossiya Segodnya Agency's international multimedia press centre.

On 14 December 2016, the AEB PR & Communications Committee jointly with the AEB Working Group on Modernisation & Innovations held a round table meeting entitled "The development of scientific and technical innovative and creative potential among young people: prospects for cooperation". The event was aimed at informing AEB members on possible cooperation in the development of scientific and technical innovative and creative potential among young people, to show the link between industrial enterprises and graduates of the professional education system.

In 2016 the topic of communications in culture formed a new section in the AEB PR & Communications Committee's agenda. In these regards the Committee held two events with museums that are among the largest and most famous in Russia- the Pushkin State Museum of Fine Arts (May 2016, Committee's open meeting) and the State Tretyakov Gallery (October 2016, Committee's open event). In both cases the events raised significant interest among the AEB PR community and provided the opportunity to learn about the museums' new projects and cooperation & partnership opportunities.

COMMITTEE ACTIVITIES, 2016

In June 2012, the AEB Technical Regulation and Standardisation Task Force became the Product Conformity Assessment Committee (PCAC). The Committee works in close cooperation with the Eurasian Economic Commission, The Committee for Technical Regulation, Standardisation and Conformity Assessment of the Russian Union of Industrialists and Entrepreneurs (RSPP), the Delegation of the European Union to Russia and Directorate General for Enterprise and Industry of the European Commission.

In 2016 the Committee continued to focus on issues related to standardisation, accreditation, conformity assessment, market surveillance, and the harmonisation of the industrial technical regulations of the Customs Union, representing the maximum interest for business, with the corresponding European documents.

On 27 April 2016, Committee members held a meeting with independent experts from the European Commission who assesed the work of the EU Project "Approximation of the EU and RF Technical Regulation and Standardisation Systems. The Committee members stressed the importance of the project and expressed their hope that the project would be ongoing in 2017.

On 20 July 2016, Committee members held a meeting with representatives of the technical regulation department of the Eurasian Economic Commission (EEC). They discussed various problems related to the application of certain provisions of the technical regulations of the Customs Union that bring about an ambiguous interpretation on the part of the national regulators, supervisory authorities and market participants.

On 8 November 2016, the Committee held the conference: "Technical Regulation and Conformity Assessment in the EAEU and EU: Prospects for Approximation". The key issues of the discussion were product conformity assessment, market surveillance, accreditation, safety and energy efficiency, the practical application of the technical regulations of the Customs Union and the EAEU, technical barriers, and its comparison to similar EU regulations.

The members of the AEB Product Conformity Assessment Committee will continue to examine the major problems identified in the field of technical regulation and standardisation, especially in respect of the EAEU.

COMMITTEE ACTIVITIES, 2016

The AEB Retail Trade Committee was established in 2010. Almost all the biggest international market players are members of the committee. The Committee deals with a number of sensitive industry issues affecting the activities of foreign retailers operating on the Russian market. The issues considered in 2016 included trade law, the alcohol trade (EGAIS in the wholesale sector), the federal law on state and municipal control, the quality system, waste management, the federal law on the special assessment of labour, electronic document interchange (EDI), parallel imports, cross-border e-commerce, and others.

In 2016 the Committee members had several meetings with governmental officials and experts such as:

- Denis Pak, Head of the Department of Internal Trade, Light Industry and Consumer Market of the RF Ministry of Industry and Trade;
- Andrey Danilenko, Ombudsman for the Protection of the Enterpreneur Rights in Trade Regulation;

On 20 October 2016, the AEB Retail Trade Committee together with the Taxation Committee held a business breakfast to discuss the amendments to trade law.

On 7 December 2016, the AEB Retail Trade Committee held a meeting with some international online trade operators with regard to possible cooperation on online trade regulation in Russia. The Committee decided to set up a special working group comprising all interested AEB members and non-members.

The Committee is composed of a number of companies specialising in various areas such as environmental protection, health & safety, security & risk management. The Committee is divided into 4 subsections – the Security Subcommittee, the Environmental Subcommittee, the Health & Safety Subcommittee, and the Climate Policy Working Group. The latter was established in May 2016 following the discussions held among interested AEB member companies.

In 2016 all the subcommittees were active and organised 10 open events. The Security Subcommittee held 3 open events, the Environmental Subcommittee held 1 big conference on the implementation of the waste management regulations, the Health & Safety Subcommittee held 4 events, and the newly created Climate Policy Working Group held 2 roundtable meetings.

The Committee worked on enhancing cross-committees activities as well as cooperation with representatives of the state authorities. In April 2016, the Committee held a joint session with the Energy Efficiency Committee on Russian Climate Policy: Developments and Prospects. In March 2016, the Committee organised its business networking event – "AEB Business Dating" designed on a model of the speed business meetings with pre-selected companies and representatives of specific function (management, HR, procurement, communications, logistics, events' organization) based on pre-assigned match ups. The event was aimed at facilitating the efforts by small and medium-sized companies in establishing contacts with the Russian operating multinational companies. As the format of the speed business meetings gives practical help in accelerating business contacts, and as it is in high demand on the part of SME companies, the Committee will continue this practice.

Another event format on the Committee's agenda in 2016 was business breakfast meetings. In May 2016, the Committee held its open event - business breakfast " Corporate culture as a context for employee and client loyalty". The participants of the event discussed the following aspects: corporate culture as a resource, the example of value creation from customer and employee retention, corporate culture as a lead generator, perspectives on corporate culture in a difficult market.

The Committee's business breakfast "Sharing best practices in solving regulatory changes" took place in November 2016. The event was held in the form of parallel roundtable discussions. During the discussions the following aspects of the issue were raised: recent amendments to trading law – areas for attention from tax and legal entities, regulations on compulsory company bankruptcy (especially for SMEs) for non-profitable business activities; anti-fire regulations and obligations, the consequences of not following them for SMEs.

The Taxation Committee deals with the most up-to-date issues in taxation as introduced by the Russian Government, and proactively develops solutions in close cooperation with the Ministry of Finance and the Federal Tax Service.

In 2016 the Taxation Committee held 8 working meetings and 4 business events which were of great value to all European and Russian executives. In addition to providing highly practical tax information, the Committee provided a platform for exchanging views and obtaining exclusive insights and recommendations from experts. The Committee's events focused on the most important taxation issues such as transfer pricing, VAT on e-commerce, taxation of SPICs, recent changes in tax law, tax administration and enforcement practices. A special event focused on retail taxation was held in October in cooperation with the AEB Retail Trade Committee. Representatives of the Russian Ministry of Finance, Ministry of Economic Development and Federal Tax Service, with whom the Committee has developed longstanding relations, were invited to speak at the meetings and events.

COMMITTEE ACTIVITIES, 2016

On 13 November 2013, the Tire Producers Working Group was transformed into the separate Tire Producers Committee. Taking into account that the technical regulations of the Customs Union "On the safety of wheeled vehicles" came into force on 1 January 2015, the AEB Tire Producers Committee believes that it is necessary to facilitate the process of the entry into force of the new requirements of the technical regulations and to continue to work on the harmonisation of the technical requirements contained in the various legislative acts of the Russian Federation: the Highway Code, the Administrative Code, the law "On technical inspection" of 2011, etc., and to continue its work on additional amendments to the technical regulations of the Customs Union on the obligatory use of winter tires. Tire manufacturers propose that winter tires are installed on the drive axle for M2, M3, N2, and N3 vehicles starting from 1 January 2017.

The tax nature of recycling payments has not been yet clarified. The new bill "On waste from production and consumption" provides two options for producers and importers: 1) the payment of an ecological fee, or 2) independently, and possibly in an association of producers and importer. Neither of the options makes it possible to carry producer costs over to the production cost or account for them as expenses in order to reduce tax. As a result, these expenses will have to be paid from net profit both for producers and importers. Right now the Committee is actively looking into the possibility of taking into account expenses to reduce the income tax, and if necessary, drafting amendments to the Tax Code.

COMMITTEE ACTIVITIES, 2016

The Coatings Working Group was established in 2016 with the objective to align the interests of coatings manufacturers in Russia. The working group was engaged in clarifying the implementation of Article 18 of the Federal Law of the Russian Federation dated 31/12/14 No. 488-FZ regarding the priority of products manufactured in the Russian Federation over those manufactured in foreign countries during state procurement giving and consequential decrees and actions. It is in the interest of the members to understand clearly these rules and interpretations so as to create a level playing field between manufacturers.

The creation of equivalent Russian and European standards for testing coating materials and the full implementation of free trade throughout the Eurasian Economic Union for coatings are also of interest to the Working Group.

COMMITTEE ACTIVITIES, 2016

In 2016 the Working Group continued with its productive and informative series of monthly meetings of hotels in the city, exchanging experiences and tackling administrative and market-driven challenges. On 15 June 2016 the AEB Hotels & Tourism Working Group Members held a business breakfast meeting attended by the AEB CEO Dr. Frank Schauff as the guest speaker. Dr. Schauff shared with the WG his vision on current market conditions, further development of the EU-Russia relations, and the AEB's priorities for 2016-2017.

Despite several extensions of the trading restrictions from the EU and the sanctions from the United States directed at the Russian Federation, 2016 showed strong improvements over the last two years in Moscow in the luxury, upscale and mid-scale hotel. The new climate of confidence in volumes and rate improvements allowed a positive outlook towards the end of this year and beyond, adjusting city rates to the new rouble reality to deliver profits and regain value for investors and owners. With the Confederations Cup ahead in summer 2017, Moscow's hotels are preparing contractually and operationally for a strong summer, supported by a recovered conference season and framed by the economic forum in St. Petersburg followed by the football festival, precursor to the World Cup in 2018.

On 19 October 2016 the Chairman of the AEB Hotels and Tourism Working Group, Mr. Armin Eberhard took part in "2018 FIFA World Cup Russia Accommodation Advisory Forum". The purpose of the 2018 Advisory Forum was to bring together key stakeholders who may contribute to the task of delivering a successful Accommodation Programme with a positive and lasting legacy for Russia's tourism industry. Members of the Advisory Forum received high level general information on the preparations for the FIFA Confederations Cup 2017 and the FIFA World Cup but with particular emphasis on all projects intended to optimized the number of international visitors to the 11 FIFA World Cup Host Cities as well as to ensure that a positive impression is created to all those who visit Russia.

On 20 October 2016 the AEB Hotels & Tourism Working Group hold a meeting with the recently appointed Deputy Director of the Department for National Policy, Interregional Cooperation and Tourism at the Moscow City Government Mr. Konstantin Goriainov. The WG confirmed its interest in maintaining the dialogue on the policy pursued by the Moscow City Government in the segment of hospitality and tourism. The WG reconfirmed its interest in aligning activities with the re-organised Moscow Convention Bureau to the representation of Moscow as a first-class meeting, conference, exhibition and congress venue in the world supported by the cooperation and participation of the city's excellent hotel industry and venue market.

On 12 July 2016, the AEB held its roundtable meeting: Robotisation, industrial automation and IOT – old problems, new solutions, together with the International Federation of Robotics (IFR) at Innoprom 2016. The keynote speakers included Gleb Nikitin, First Deputy Minister of Industry and Trade; Alexey Texler, First Deputy Minister of Energy; Andreas Bauer, Chairman of the IFR Robot Supplier Committee; Ralf Bendisch, CEO, Claas; Alexander Verl, Chairman of the Research Committee of the International Federation of Robotics, Full Professor and Head of the Institute for Control Engineering of Machine Tools and Manufacturing Units (ISW), University of Stuttgart; Ramesh Nimmagadda, Professor, IIT Madras; Boris Melenevsky, Chief Architect, SAP. On 12 July 2016, Ruslan Kokarev took part in a meeting with Denis Manturov, Russian Minister of Industry and Trade, with international business representatives, CEOs of leading industrial companies and heads of foreign chambers of commerce and professional associations working in the Russian Federation. The meeting participants raised the most important issues concerning their work in Russia. Representatives of AEB member companies were also among the participants of this high level meeting. For the third year in a row the AEB supported Innoprom. The forum's main topic in 2016 was the Industrial Net. The combination of INDUSTRY+INTERNET is one of the main drivers behind the new industrial revolution that will facilitate the creation of highly efficient digital production facilities. Russia's top government officials and heads of major international industrial companies discussed the Industrial Net at the main strategic session of INNOPROM.

On 20 September 2016, the AEB held the presentation of the Agency of Technological Development (ATD): Opportunities and mechanisms for cooperation. The agency was represented by Maxim Shereykin, Chief Executive Officer, Agency of Technological Development. The agency aims to help Russian companies implement world-class technology solutions in order to achieve the competitiveness of domestic products. The agency is involved in international technological expertise, the provision of a supermarket of modern technological solutions, the search and transfer of global breakthrough technologies, the technological upgrade of Russian companies; the development of a supplier base for big companies. Its priority sectors are mechanical engineering, the agro-industrial sector, pharmaceutical and medicine, the construction industry, energy saving and energy efficiency projects, petrochemical, information and communication services.

On 27 October 2016, the AEB held its session: Technological aspects of joining the Asian Super Ring at the Open Innovations Forum 2016. The session was organised by the Working Group on Modernisation & Innovations and was moderated by Michael Akim, Chairman of the working group, Vice President, ABB Russia. The speakers were Elena Gorchakova, Executive assistant of the Minister, Ministry for the Development of the Russian Far East; Bo Nilsson, Head of Sales Middle East Africa, ABB AB, Sweden; Alexander Sergeev, En+ Group; and Alexey Ponomarev, Vice President for Strategy and Relations with Industry, Skolteh. The aim of the session was to discuss and analyse the measures required to implement the energy ring project, which would connect Russia, China, South Korea and Japan. This project was recently proposed by Russian President Vladimir Putin. This year the forum took place in Skolkovo Technopark. On 26–28 October 2016, it hosted more than 90 various events organised in an interactive format: from panel discussions, presentations and lectures to workshops, pitch sessions and hackathons. The AEB WG on Modernisation & Innovations assisted in the organisation of the AEB meeting with Robert-Jan Smits, Director-General of DG Research & Innovation at the European Commission, which took place on 11 November 2016. The aim of the meeting was for Mr. Smits to hear not only the views of European business on the general economic climate in Russia but also the prospects for developing research & innovation focused cooperation, utilising Europe's and Russia's intellectual and scientific capital and technological complementarities. Companies also discussed with Mr. Smits the general framework conditions for carrying out R&D activities in and with Russia.

On 6 December 2016, the AEB Working Group on Modernisation & Innovations held an open meeting dedicated to the topic: R&D and innovations: cooperation between business and science. The aim of the meeting was to discuss and share experience of cooperation between European companies and Russian research institutes and universities in Russia. Interested AEB members were informed about business prospects and opportunities for cooperation in science, technology and innovation.

Myron Wasylyk, PBN Hill+Knowlton Strategies, CEO – Russia, Ukraine, Kazakhstan & CIS, provided a comprehensive review of the research on innovation in Russia which outlined the prospects, challenges and drivers for the development of innovation in Russia. Dr. Andreas Gut, State Secretariat for Education, Research and Innovation SERI, Switzerland, shared the experience of Swiss innovative companies and their international cooperation under the inter-governmental EUREKA initiative. Alexander Tkachev, Head of the National Eureka Project Office, Centre of Innovation Technologies and Engineering of Moscow Technological University, elaborated on the structure and essence of the EUREKA programme and talked about the opportunities for Russian companies to take part in this intergovernmental program. Richard Burger, Research & Innovation Counsellor, Head - Science & Technology and other EU Policies Section, Delegation of the European Union to the Russian Federation, presented the first results and examples of the participation of Russian players in EU's Horizon 2020 programme. Jens Perregaard, General Director at Haldor Topsoe, presented a vivid example of the Topsoe approach to engaging with Russia via science.

On 14 December 2016, the AEB WG on Modernisation and Innovations together with the AEB PR-Committee held a roundtable meeting: The development of scientific and technical innovative and creative potential among young people: prospects for cooperation. The aim of the event was to inform AEB members on possible cooperation in the development of scientific and technical innovative and creative potential among young people¬, linking industrial companies and graduates of the professional education system. The roundtable meeting was moderated by Michael Akim, Chairman of the AEB WG on Modernisation & Innovations, Vice-President, ABB Russia. Ivan Bortnik, Member of the Supervisory Board of the Association of Innovative Regions of Russia, Head of the Department of Innovation Management, Higher School of Economics, spoke on the creation of educational centres for talented and gifted children (including the Sirius Centre and others) and invited the AEB member companies to bridge the dialogue between Russian and European talented children and to share their experiences with the younger generation. Victoria Soboleva, Director of the Organising Committee of the International Festival of Children's and Youth Scientific and Technical Creativity Ot Vintal; Chair of the Commission on the development of children's and youth scientific and technical creativity of the Public Council under the RF Ministry of Industry and Trade, informed the participants about opportunities for cooperation with the Ot Vinta youth festival which was established to promote the creative and innovative potential of children and young people. Elena Voskoboynikova, Deputy Director of the Department for marketing and partnerships, WorldSkills Russia, talked about the young professionals movement WorldSkills Russia and the possibilities for cooperation in the development of vocational education and enhancement of the prestige of working professions. Vladimir Frolov, Director of the Department of Programmes for the Management and Modernisation of the Moscow Polytechnic University's campuses, talked about student competitions in the field of energy efficiency and the promising ways to develop innovative creativity among young people. Sanofi's experience in working with talented youth in business was presented by Ivan Burkov, Product Planning Manager, Sanofi Eurasia, and Elena Zdanova, Recruitment Project Manager, Sanofi Eurasia.


