## OUTCOMES OF THE XII EURASIAN ECONOMIC FORUM

24–25 October 2019, Verona, Italy

The Forum featured discussions on a wide range of practical issues related to economic cooperation and trade from the Atlantic to the Pacific. The importance of establishing dialogue between the European Union and the Eurasian Economic Union across numerous areas came under particular focus. Discussions also centred around issues concerning energy and energy security, the development of financial markets, new technologies, and infrastructure projects, amongst other topics. It was also the first time that a social issue took centre stage at the Forum – that of inequality as one of the factors arising from the global financial and economic crisis. 100 >100 speakers media representatives
